## Haverstraw Achieves Green Business Certification

The Haverstraw King's Daughters Public Library (HKDPL) has achieved Green Business Certification by the Green

Business Partnership (GBP) as the first step of seeking certification under the Sustainable Libraries Initiative. HKDPL is the ninth public library to be certified by the GBP, out of 756 public libraries statewide.

By becoming a Certified Green Business, HKDPL is modeling best green business practices and a commitment to continuous improvement. The library

# Library Visits Outpaced Going to the Movies in 2019

Gallup, Jan. 24

Visiting the library remains the most frequent cultural activity Americans engage in, by far. The average of 10.5 trips to the library that US adults report taking in 2019 exceeds their participation in eight other common leisure activities. Americans attend live music or theatrical events and visit national or historic parks roughly 4 times a year on average and visit museums and gambling casinos 2.5 times annually. Trips to amusement or theme parks  $(1.\overline{5})$  and zoos (0.9) are the least common activities on this list. Women report visiting the library nearly twice as frequently as men, and adults aged 18–29 visit the library much more than all older age groups.
